MESSAGE FROM THE PRESIDENT **President's Message: The Journey**

You always hear people say life is a journey. What you rarely hear people say is your career is a journey. They obviously are not court reporters.

When I found out or heard "Fantastic Journey" as one of the choices for this year's conference, it clicked with me immediately, and I knew that that was going to be my theme for this year. We all have a story and we all have a journey that we can share with other people, and I want to share mine with you today.

When people ask why I became a court reporter, I tell them there were three reasons: I'm horrible at memorization, I hate math, and this is what my father told me I was supposed to do from a very young age. When I was eight years old, my father introduced me to a court reporter named Joy Hayes, who is present at the convention this weekend, and said, "Honey, this is what you're supposed to do when you get older." At eight years old, I didn't want anything to do with anything my father recommended, so that was it.

When I was 15 years old, he introduced me to another court reporter named Candy Morgan and once again said, "Honey, this is what you're supposed to do when you get older." Candy said I crossed my arms and tapped my foot and didn't listen to anything she had to say. And once again, it was my father's suggestion, so it meant nothing. Well, in my senior year of high school, for career day, we had a court reporter speak. And from that day forward, I knew I was going to be a court reporter. There was nothing else I wanted to do. I fell in love with it and that was going to be my career.

When I first started court reporting, I ended up working for Candy Morgan, the reporter who I had met when I was 15, and she's reminded me for 21 years what a brat I was when she first met me. My last year of school I worked for Central Florida Reporters for Susie England in Orlando. And through the years Susie has become my very best friend.

When I started my interning, working for Central Florida Reporters, I was lucky enough to work with one of the best court reporters I have ever known, Laura Landerman, who is captioning for us today. And Laura also a couple years ago, it may have been last year, actually, or two years ago, won the Arlene P. Sommers Award for the amount of students who she has mentored through the years.

Laura taught me more than anyone could have taught me. She taught me my Eclipse software. I got to go sit in court and scope with her, which back then is how you scoped. You had a reporter sitting next to you. I learned more from her than I ever learned in school, and she has been a godsend

to my career.

THE REPORTER: Thank you, Christy.

CHRISTY BRADSHAW: My first few years reporting, I was in Inverness, Gainesville and Ocala. Not unlike most of us in here, I was absolutely scared to death. The first six months of my career I wore scarves because, as you all know, I break out in hives, so every time I went to swear a witness or had to read back, I was just covered in hives. It was quite an experience, but I made it.

One of my very first jobs was a three-day jury trial where the judge, who was a friend of my father, had to come find me in the bathroom because I was throwing up and said, you know, come in here. We're going to take care of you. It's going to be okay. And it was. I made it through the trial, and I had a couple minor hiccups, which is another really good story I can tell, but I did it. I made it through.

In 2000, my husband and I were living in Neptune Beach, Florida. He was in law school. And our apartment flooded and we were forced to move. We moved to my parents' lake house just south of Ocala, which was free at that time. So we moved in there, and it was at that time that I decided to start my own business, CAB Reporting, out of the loft of my parents' lake house. We had no money. I had no office. I had a handful of clients, and I had the support of my husband and the support of my family. My dad had retired from being a judge and was a mediator, and every mediation he went to he handed out my cards. He was always my biggest fan.

In 2001, I got my first office. A couple years later I got a bigger office, and then I got the one that I am in now, which I've been in for about 13 years. I passed the RPR. I passed one leg of the RMR and was really starting to believe in myself.

In 2006, I attended my first firm owners conference in Sarasota. I went by myself and didn't think I would know anybody there. The first person I ran into was Susan England, who had been my boss when I was in court reporting school. We spent the whole weekend together, and we have been inseparable since that weekend. I also met for the first time Jennifer Gaul and Susan Wasilewski, who encouraged me to attend an FCRA conference, which I had never been to. Because of the two of them, I attended the very next FCRA conference and every one that has followed.

One of the next conferences I did attend at FCRA, I decided to raise my hand and ask a couple questions and make a couple comments, which was a big move for me.

MESSAGE FROM THE PAST PRESIDENT **Immediate Past President's Speech**

The next order of business is the president's report, and I'm happy to report that we have had an outstanding year. Right after our last convention, our committees hit the ground running, and one of the first accomplishments was another successful FPR where 26 out of 32 reporters who attended became FPRs for an 81.25 percent pass rate.

In February, we participated in the National Court Court Reporting & Captioning Week campaign. And I'm sure you all remember the wonderful poster we put together and displayed throughout all the courthouses in the state that we could get to. So many people participated, and it was an outstanding success in the respect that we got such positive feedback.

We've had some great PR, and we had a good time doing it. National was proud of us to the point that they included our poster in their article, so I would say mission accomplished on that one.

In March, we attended boot camp in DC put on by NCRA. It's a legislative boot camp they hold every other year as a tool for aiding state association leadership to be able to advocate and legislate and just advance whatever your issues may be. It was an outstanding experience. Lori Bundy, our vice president, attended, Sharon Velazco, our secretary, and myself. And not only did we learn so much, but we absolutely did advocate for our profession. We stormed the Hill, and we showed them what realtime reporters are all about right there on their television screens, and that, too, was very successful. And we all feel so much more empowered as a result. (Applause)

In April, continuing on our path of success, we went to the University of Miami, and we spoke to the third-year law students once again. This became an annual event for us where we go and talk to them about the different methodologies and why ours is the preferred methodology. We do realtime demonstrations. We answer their questions. And this particular year we really were touched by a student who came up to us when the class was over, and he shared with us the fact that he was hearing impaired. And one of his greatest concerns going forward was the challenge he may be met with when proceedings were going on and he may not be able to hear and understand everything. He came up to us afterwards, and he said, "I can't tell you how relieved I am to know that this exists and this is exactly what I'm going to need when I start practicing law." So, again, mission accomplished.

We were so touched, and I almost burst into tears right there. Again, you just don't know who you're touching and

how our jobs are interwoven in people's lives, and that day we gave him the reassurance he was going to have all the tools he needed to go forward, so that was excellent.

And as an aside, I had the occasion to meet with the president of The Florida Bar just because he happens to be in South Florida, so I got the opportunity, and we sat and talked about a lot of issues. And when I told him that we do this, go to law schools and speak to the students, he thought that was phenomenal. He said you guys should be doing that wherever possible because these attorneys don't get any of that. They only get the education they get wherever they first land to take their first depositions, and they really have no idea about so much of the detail that goes into your job. So he thought that was very effective. And the professor himself loves it, and every year, it's "See ya next year." So it's grown, and thanks to NCRA putting together an excellent

guideline that we use, and we've encouraged other state associations to do the same thing. And if anybody here would like to do this in universities or colleges in your area, please reach out. We'll be happy to share the script and let you know how we do it, and the more the merrier. We need all the volunteers we can get.

In May, we had very successful Off The Record network gatherings, and those who attended know that not only did we have great turnouts, but for the first time, we had some VIPs in the house. We invited our local judges and elected officials, and every ROR was attended by someone in office.

We were very lucky in Miami. We had about 12 judges at ours. They were thrilled, and they thought it was a wonderful idea. And we realized, boy, what an opportunity missed by not doing this in the past, because we don't ever get to interact with our judges. And they, more importantly, said, "We don't get to interact with you guys. You work all day and you're in our courtrooms, we're on the bench, and we just never get this opportunity."

So they really, really were happy to be a part of it, and in the future, we'll keep doing that, and hopefully our event will continue to grow.

Even some of the reporters were just stunned to see the judges there. They felt so privileged, and someone asked me, "Well, why did they come?" I said, "Because we invited them." Gee, what a concept. So it was really, really successful, and we will definitely do that again. So, as I said, I'm happy to report our year has been outstanding.

Also, on top of all of that, our Professional Ethics Committee did an outstanding job this year.

Once again, they fielded questions all year long. You would be amazed at the things that come up, the little things that our entrusted committee deals with on a regular basis. As Donna says, they kind of come in spurts. We'll have a quiet time, and all of the sudden, we'll be slammed with three or four different, very perplexing questions. And the committee does their research, has meetings and does whatever it can to assist that reporter so they go out and represent the profession professionally and with the tools that they need to be successful and not make mistakes. So that's been quite challenging all year for that committee.

We were also contacted by the Florida Supreme Court. Those of you who picked up a copy at the registration desk of the rule change to Rule 9.210 where they updated some of the appellate procedures for the record on appeal because of us moving towards electronic filing and trying to streamline some of that procedure, they were gracious enough to reach out to FCRA and allow us to have input into some of the proposed changes. And that was critical because, once again, they don't know our job very well and don't know what the mechanics of it are. And, by us being able to give that input, not only did the rule come out in a way that was much more advantageous for us, but they actually credited us with helping them.

So that was a great bridge that we established with the Florida Supreme Court as we move forward on other issues. They know that we're supportive of them and they're supportive of us, and it can only just move forward from here due to the fact that we're building these relationships as we go along. So we're very proud of that as well.

Also, certification. I know you're all dying to hear all about that, and that's another committee that has worked diligently all year to address this issue and to advance our biggest cause. And I'm very happy to report that OSCA, Office of the State Court Administrator, which P.K. Jameson is the state court administrator, they met with us. Our committee went up to Tallahassee, and they met with the committee that OSCA put together and discussed what our goals are and how we could accomplish them.

And I'm very pleased to say that one of the first things that came up and they agreed with was a registry, that we need to start identifying the court reporters in the state before we can start talking about actual certification. And the last we heard, OSCA just got approval for six full-time employees added to their staff, two of which will be dedicated strictly to the court reporting registry and certification. (Applause)

We are closer than we've ever been to reaching our goal, so that is an outstanding accomplishment, really.

As I said, you can see we've been very busy this year. And honestly, I don't know how much more could be expected from a board that is all volunteers. We're all either working reporters or firm owners, and I don't have to tell you how hard that is in a profession like court reporting to then juggle all this volunteer stuff. Things that are thrown at you.

There's the planned. There's the unplanned. And it just — it rolls, and somehow we just manage to get it done. So this board has been outstanding. I just want to thank you all. (Applause)

Our wonderful editor-in-chief did a fantastic job this year with our online magazine getting people to publish articles. That, in and of itself, is a huge accomplishment, not to mention the fine way she put it all together, along with her little musings of Vana Lou.

And we've also tried to keep you informed and up to date with our e-flashes. So anybody who's read those as they've come along, I'm sure, has appreciated the information and the way it's helped you.

And this convention. We've put on a fantastic convention. And that's really the royal "we" because it's she, but she really has done an amazing job, stepped up and put together this wonderful event. And I know you all have been having a good time, right?

The location is wonderful, but the agenda is what's really important so that you all come here and take something away besides just a good time. And I hope we've done that for you and given you the tools you need to be even more successful to take it to the next level. So you are an amazing party planner, young lady, and we thank you very much for that. (Applause)

It appears that it was an "invitation" that had gone out from my FB! If I hadn't gotten that PM, I doubt that I would have even noticed it, as I generally just scroll right past that sort of thing.

Immediately trying to find out what this was, I Googled "Rayban FaceBook." I had barely finished the words when Google offered "Rayban FaceBook Hack." (If you're completely bored already, open Google and type "Google fini" – just that much, and you'll be treated to "Google finishes my sentences.")

This is just one of the many hits that came up: "Why is there so much RayBan spam on FaceBook?"

Choosing one at random, I was led (by the nose) to a FaceBook Help page. "I seem to be spamming all of my contacts with an invitation to a RayBans charity sale that I have never seen and I can't see it on my timeline either to stop it!"

The page suggests that you've unwittingly loaded a FB app that's causing this intrusion into your Facebook account, and tells you to go to your Settings, Apps. So I did. Like me, she doesn't remember ever asking for or "signing up" for many of these,

although, like me, she's a member of or Likes pages of some of them such as Bored Panda, Change.org and Mad Men. But does just Liking a page install an app without your consent?

It may be that simply clicking on a link in some of those posts does. A friend (a "real life" friend, not just a FaceBook Friend) wrote me, "not saying you do but anytime people do those things on FaceBook like the current 'how big is your vocabulary' it gets an 'app' added that mines all your crap. "

In the family discussion, my niece checked her Apps setting and found nothing she hadn't purposely put there, and she wrote: "I don't know if the reason I don't have stuff is because when I take quizzes, I don't post my results from the quiz itself. I just type my result or take a snippet or screen shot. I have high security settings, too."

I don't play FB games and I'm pretty sure I've never done any of those surveys. But I was reminded that every time I

finish a Kindle book on my Amazon Kindle app on my phone, it asks me if I want to post to FaceBook that I've read the book.

No. No, thank you.

The FaceBook Help page continued to be not really HelpFul, continuing to state obvious solutions such as running a virus scan (Did that. I was clean.) Changing your password. (Didn't. I wanted to see what happens next, if anything. Consider it Research. Oh, what I do for you guys...)

I checked the Apps page three days after the RayBans Event. Thankfully, nothing there, but I'll sure be keeping an eye on it from now on.

By the way, several people have asked me how to check the Apps page. On your main FaceBook page, click this down arrow, click Settings, then on the next page, click Apps, found on the left margin.

After my literal rude awakening, eventually I had to go on with my real life day, and as usual, during lulls in my life I'd wander through FB, and for the rest of the day, everything at least seemed normal.

That evening, as I sat on the couch watching our current NF (NetFlix) binge, a series called Person of Interest, which is a fictional (or is it!?) series about all the ways the government can see us with cameras everywhere, a message popped up on my phone and warned me that my I've tried to log on from another device, my FB has been frozen due to possible fraud and that I need to confirm that it was me. It wasn't, obviously.

It took several tries but FB finally allowed me to change my password.

I almost looked madly around my living room to see if there was one of those gummint cameras looking at me right now. Almost. I'm not quite that loony, but it reminds me, as I write this, of the first time cable TV finally made it to our then-rural neighborhood, some 25 or 30 years ago, and I called to sign up for installation, got a wrong number. Oh, BOY, did I get a wrong number. The said wrong number then proceeded to treat me to a rant about the evil cable empire that has conspired with the government to let our TVs spy on us through the cable connection. That almost doesn't seem so farfetched right now.

<mental slap> No, Donna, I said, don't BE that paranoid. But then I remembered that just because you're paranoid, doesn't mean someone isn't out to get you....

Despite a lot of nosing around, I have yet to discover HOW this happened. But I was shocked to see how many hacking tools are out there, blatantly screaming their abilities on yet another Google search:

This one was my favorite. "Ethical Hacking"?? 5 Steps How to Hack FaceBook Account Password | Ethical Hacking ... www.hacking-tutorial.com > Hacking Tutorial

There's even a YouTube video on how to hack FaceBook. (Darn, wish I'd known that when I did my YouTube-themed article a few months ago!)

On your FB page, in the Search box, type "RayBan invitation." I'm not alone. There are dozens of posts. Including mine, where people are notifying their friends of the scam. And it's been around for years. The earliest indication I found of it is 2011.

In the discussion where I posted to my friends not to click on it, several commented that they'd gotten one, but figured it was so out of character for me that it had to be fake, and knew better than to click on it. I pointed out that, yes, my REAL friends, not just my FBFs, who really DO know me, know me that well!

These are scary times we live in, my friends – my real-life friends, and my FBFs. And I'm not talking about the current presidential election season.

I had really hoped to understand why. Why me? Why now? Why RayBans? As well as How. HOW did somebody get into my FB? Then there's the What Else? Have they gotten other sensitive personal information from me? I'm very careful about what I let FB know about me, at least knowingly, but seeing all those apps that I absolutely did not load myself, I admit, scared me. And getting that log-in notification really creeped me out. Especially while I'm watching Person of Interest.

The last thing I need to say is, if you're one of my FBFs, and if you DID click on the bogus invitation, you're probably compromised too, and you should at least change your password.

FaceBook can be a wonderful thing. It can also be a dangerous thing. It's a great way to keep up with your family and real life friends, a marketing tool for your business, a way to network with your colleagues, get advance news and behind-the-scenes information about your favorite authors, TV shows and celebrities. Just remember that it has many dark alleys and scary places, too. BE SAFE OUT THERE!
